The themes of identity and belonging are particularly important in Desai's fiction because her characters frequently struggle to locate themselves within rapidly changing social and cultural contexts. They are often caught between tradition and modernity, homeland and hostland, memory and reality. Gradually, people begin to treat him as a holy man, though his withdrawal is more a personal escape than a spiritual achievement. Through satire, humour, and fantasy, Desai explores Indian middle-class society, public curiosity, family pressure, religious belief, and the human desire for freedom.

Although *Hullabaloo in the Guava Orchard* is not a direct diasporic novel like *The Inheritance of Loss*, it still reflects important concerns related to identity and belonging. The novel presents a form of internal displacement rather than international migration. Sampath does not leave India for another country, but he feels alienated within his own family, workplace, and society. His escape into the guava orchard symbolizes his rejection of social expectations. In this sense, Sampath becomes emotionally displaced within his own homeland. Desai shows that displacement is not always geographical; it can also be psychological and social (Desai).

The theme of identity is central to the novel. Sampath is unable to fit into the role expected of him by his family and society. His father, Mr. Chawla, wants him to become successful and respectable, while his mother and grandmother represent domestic expectations and traditional values. However,

Sampath cannot accept this fixed social identity. When people begin to worship him as a spiritual figure, a new identity is imposed upon him. Ironically, this identity is also false because Sampath does not intentionally become a saint. Desai therefore shows that identity is often shaped by society's expectations, public imagination, and misunderstanding rather than by the individual's true self (Desai).

Belonging in the novel is shown as a difficult and unstable experience. Sampath does not feel that he belongs in his office, family home, or social world. The guava tree becomes his alternative space of belonging. It gives him freedom from discipline, routine, and social pressure. However, even this private space is soon invaded by devotees, family members, officials, and curious townspeople. This shows that society often refuses to allow individuals complete freedom. Sampath's search for belonging becomes complicated because every space he enters is controlled by others.

The novel also reflects the tension between individual desire and collective social identity. Sampath wishes to live quietly and freely, but the people of Shahkot turn him into a public figure. His personal escape becomes a social event. Through this, Desai criticizes the way society constructs identity for individuals and then forces them to perform that identity. Sampath's transformation into a supposed holy man reveals how quickly communities create myths around people who appear different. His identity is therefore not self-created but socially manufactured.

From the perspective of diaspora, *Hullabaloo in the Guava Orchard* may be read as an early exploration of alienation and unbelonging, themes that Desai later develops more directly in *The Inheritance of Loss*. In this novel, diaspora is not represented through migration abroad but through Sampath's estrangement from his own cultural environment. His condition suggests that a person can feel like an outsider even within the homeland. Thus, Desai broadens the meaning of displacement by showing that alienation can exist inside familiar spaces.

He remains socially invisible because of his immigrant status, poverty, and racial identity. His longing for India increases as he faces humiliation abroad. This shows that the diasporic subject often remains divided between the desire for economic success in a foreign land and emotional attachment to the homeland. Biju's return to India at the end of the novel suggests that migration may not always lead to belonging or fulfilment (Desai 310–24).

The theme of identity is strongly represented through the character of Jemubhai Patel, the retired judge. Jemubhai's identity is deeply damaged by colonial influence. During his education in England, he becomes ashamed of his Indian background and tries to imitate British manners, language, and lifestyle. However, he is never fully accepted by the British, and after returning to India, he remains alienated from his own people. His character shows the psychological effects of colonialism, where the colonized individual develops self-hatred and cultural confusion. Desai uses Jemubhai to show how colonial identity can become fractured, unnatural, and painful (Desai 37–45).

Sai, Jemubhai's granddaughter, also experiences confusion regarding belonging. She grows up in an English-speaking, Westernized environment and is distanced from ordinary Indian social life. Her relationship with Gyan exposes differences of class, ethnicity, language, and political identity. Through Sai, Desai shows that belonging is not only connected to geography but also to class, culture, education, and history. Sai lives in India, but she does not fully understand the society around her. Her identity is therefore shaped by both privilege and isolation.

The novel presents belonging as unstable and difficult. Almost every major character feels displaced in some way. Biju does not belong in America; Jemubhai does not belong either in England or India; Sai does not fully belong to the Indian society around her; and Gyan struggles between personal love and ethnic-political identity. Desai suggests that belonging is complicated by colonial history, migration, poverty, and social inequality. The title *The Inheritance of Loss* itself suggests that the characters inherit not wealth or security, but loss, displacement, shame, and fractured identity.

In comparison with Jhumpa Lahiri's diasporic fiction, Desai's treatment of diaspora is more political and historical. While Lahiri often focuses on family, memory, naming, and second-generation identity, Desai connects migration with colonialism, class struggle, racial hierarchy, and global economic inequality. Biju's immigrant life in America becomes a sharp criticism of the global dream that promises success but often produces exploitation and alienation.

Overall, *The Inheritance of Loss* is highly relevant to the theme of diaspora, identity, and belonging. The novel shows that migration does not automatically create progress or happiness. Instead, it often produces loneliness, cultural confusion, economic struggle, and emotional dislocation.
